#### Registration Terms

**CANCELLATIONS:** All cancellations must be in writing and faxed to 310-416-9055 or e-mailed to [programs@pihra.org](mailto:programs@pihra.org). Cancellations received before June 30, 2010 will be assessed a 25% cancellation fee. 50% of the registration fee will be refunded for cancellations received from July 1 – September 3, 2010. Cancellations received after September 3, 2010 are nonrefundable.

**SUBSTITUTIONS:** All substitutions must be submitted in writing to [programs@pihra.org](mailto:programs@pihra.org) by September 3, 2010. All other substitutions will take place at the onsite registration booth. If a PIHRA member transfers his or her registration to a non-member, the non-member must do one of two things: Pay the difference between the member and non-member rate at the time of transfer or become a PIHRA member at the time of transfer. Only one substitution allowed per registrant. No split registrations.
