Please note that as a Board Officer, you will be required to attend all meetings of the Board (typically six per year), and fulfill all other responsibilities applicable to your position on the Board.

A representative of the Nominations Committee will confirm receipt of your material and will schedule and conduct a telephone interview.

The PIHRA Board of Directors will meet on **Wednesday, October 14, 2020** at 5:00 p.m. virtually via Zoom. Candidates will be invited to attend and offer a two- or three-minute presentation of their platform and what they will do in their volunteer leadership role, if elected. The Board will conduct an electronic secret ballot election during the week following the Board meeting. Ballots will be tallied and elected candidates will be notified by mid-October.
