A representative of the Nominations Committee will confirm receipt of your material and will schedule and conduct a telephone interview.

The PIHRA Board of Directors will meet **on Wednesday, October 12, 2021 at 5:00 p.m.** virtually via Zoom. Candidates will be invited to attend and offer a two- or three-minute presentation on what they intend to contribute in their volunteer leadership role, if elected. The Board will conduct an electronic secret ballot election during the week following the Board meeting. Ballots will be tallied, and elected candidates will be notified by mid-October.
